

- 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.
- 4. The program has been granted accreditation for further 3 years. Sri Krishna College of Engineering and Technology, Sugunapuram, Kuniamuthur Post, Coimbatore- 641 008, Tamil Nadu should submit fresh online application through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.
- 5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to Sri Krishna College of Engineering and Technology, Sugunapuram, Kuniamuthur Post, Coimbatore- 641 008, Tamil Nadu as a whole.
