Sri Krishna College of Engineering and Technology, Sugunapuram Kuniamuthur Post, Tamil Nadu-641008 should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above to be eligible to be considered by the concerned Committee in NBA for further processing of the accreditation status.
