Additionally, legislation will mandate gender equity in education reporting, ensuring accountability and fostering collaboration with local communities, NGOs, and the private sector to enhance women's educational outcomes.

WOMEN APPLICATION RATE (WAR):

$$\text{WAR} = \frac{\text{Number of Women Applications}}{\text{Total No. Of Applications}} = \frac{1211}{3323} = 36.44\%$$

RATIO:

WOMEN ENROLLEMENT RATE (WER):

$$\text{WER} = \frac{\text{Number of Women Enrolled}}{\text{Number of women Applications}} = \frac{485}{1211} = 40.04\%$$
